3. [Call](#) both of your US Senators and politely demand that if articles of impeachment should be sent to the Senate, that they vote to convict Holder.
4. Standby for articles of impeachment to be provided by The Truth Watch. We are currently working with a group of patriot lawyers to help us write up articles of impeachment that we can send to our US Representatives and politely demand that they submit them to the House of Representatives.
5. Let us Truth Watch members start banging the "Impeach Eric Holder" drums locally to get a groundswell of support so we can convince our particular US Representative to support impeaching the Attorney General.

If we can convince the House of Representatives to impeach Eric Holder, at least we can get him to resign. At best, the Senate tries the case and with the preponderance of evidence, it will be hard for any Senator (other than the statist) to vote against conviction. At the very least, we put Congress and the Obama Administration on notice that WE the People are serious about returning the power back to us.
